As I mentioned in my letter to you yesterday, I am today enclosing Jaime's ticket on TWA from Philadelphia to Paris, and return to Philadelphia from London (via Boston).

As there are no through flights on Thursdays from Philadelphia to Paris, this ticket cover a TWA flight # 900 leaving Philadelphia at 5:00pm., arriving Idlewild in New York about 5:51pm, transferring to TWA flight # 800, leaving New York at 7:30pm, June 17, and arriving Paris next morning (at 7:15am., I am told, but I strongly recommend you to check this time your self). I am advised Jaime can check his baggage through to Paris at the Philadelphia airport, avoiding on his part the bother of seeing his baggage transferred in New York.

His return ticket is also via TWA form London to Philadelphia (via Boston, no change of plane) on Ang. 70.

The ticket is made up as a round trip ticket from Philadelphia to London, to give the lowest overall fare, plus a one way ticket from London to Paris, even though actually he flies the Atlantic to Paris direct untant going to London on his eastbound flight.

Jaime's air fare, as total on his ticket, is \$531.50. One half the cost of reservation at the Strand Palace, London and the Hotel Bedford in Brussels, plus Jaime's passenger fare on the ferry, Calais to Dover, come to \$14.93 (which I have paid) which added to the above makes \$546.43. Since you sent me \$552.20, you were entitled to a refund of \$5.77. Actually, I made a slight error in my arithmetic and sent you \$6.07, but please do not bother to waste time sending me that 30 cents.

I believe I told you some months ago, that as Ted was furnishing the car for the transportation of soll, I felt he was entitled to be reimbursed for  $\frac{1}{2}$  of what it would cost to rent the cheapest car available in Europe for the period June 16 to Aug. 13, to which as I shall, you agreed. I find the lowest rate obtainable would be for a Volkswagen, and it would come to \$400 (rental only, exclusive of gasolina). If this appears to you to be reasonable, will you please send me a check for \$200 for Jaime's half, as I have already advanced the money necessary to pay in full for Ted's Porsche (which comes to around \$4000, with insurance and ocean transportation).

As we are leaving here in a few days to wait Mary for three weeks before returning to Maine, please send the check and all further letters and suggestions you may have, to me at Mary's address at dskfsdjdsI Pollard, 263 Washington Circle, Lake Forest, Illinois.
